| 3. Purpose: | To encourage and assist high-achieving Nigerian candidates to pursue a postgraduate programme at the University. |
| 4. Duration of scholarship: | The duration of the scholarship is for the duration of the recipient's course, up to a maximum of three academic years. |
| 5. Concurrent scholarships: | The scholarship may be held concurrently with any other scholarship or award, provided that this has been approved by the selection committee and is permitted by the conditions of the concurrent scholarship or award. |
| 6. Eligibility requirements: | To be eligible to be considered for the scholarship, a candidate must— (a) Be a student resident in Nigeria; (b) have applied for a place and admitted in the postgraduate programme at the University; (c) have a minimum of 3.5/5.0 CGPA for a 5/7-point grade system. (d) have submitted an essay or personal statement explaining his/her academic and career goals, achievements, and why he/she deserves the scholarship; |
| 7. Eligibility to take up: | The scholarship must be taken up in the academic year for which it is awarded. To be eligible to take up the scholarship, an awardee must have been offered and accepted admission in James |
